

# KEYNOTE SPEAKERS



# Mi(HAEL J. (HANOLER, PhD

## Professor Emeritus, The University of British Columbia, Vancouver, Canada

Professor Chandler is a developmental psychologist, Professor Emeritus, and Distinguished CIHR and MSFHR Investigator working at the University of British Columbia. His ongoing program of research explores the role that culture plays in setting the course of identity development. In particular, his work has made it clear that both individual youth and whole Indigenous communities that lose a sense of their own personal and cultural continuity are at special risk to suicide, and a host of other negative outcomes, including high accident and school drop-out rates. These efforts have earned Dr. Chandler the Killam Memorial Senior Research Prize, the Killam Teaching Prize, and to his being named Canada's only Distinguished Investigator of both the Canadian Institutes of Health Research and the Michael Smith Foundation for Health Research, and resulted in his being chosen as a member of the Advisory Board of CIHR's Institute of Aboriginal Health. Professor Chandler's program of research dealing with identity development and suicide in Indigenous communities was singled out for publication as a book and an invited SRCD Monograph, and is the only program of Canadian research featured in WHO's recently released report on the social determinants of health.

# JUNE OSCAR AO

Chief Executive Officer, Marninwarntikura Women's Resource Centre, Fitzroy Crossing, Western Australia

June is the Chief Executive Officer of Marninwarntikura Fitzroy Women's Resource Centre and a proud Bunuba woman from the remote town of Fitzroy Crossing.

June is a champion for Indigenous Australian languages, social justice, women's issues and Foetal Alcohol Spectrum Disorder.

In 2007, she fought successfully for alcohol restrictions in Fitzroy Crossing. Her focus on Aboriginal children and her determination that we do not sacrifice the health of children for the 'right' to buy full strength take-away alcohol, made her a role model for all Australia.

In 2011, in an article appearing in The Age and Sydney Morning Herald, June was named one of the 50 most influential women in the world for her work in improving the lives of those living in remote Aboriginal communities.

June is co-founder of the Yiramalay Wesley Studio School and in 2012 she was appointed as an Ambassador for Children and Young People by Western Australian Commissioner for Children and Young People, Michelle Scott. In 2013, she was awarded an Order of Australia (AO) in the Queen's Birthday honours. June was the winner of the Westpac and Financial Review 100 Women of Influence 2013 for Social Enterprise and Not for Profit Category. In 2014, June was awarded the Menzies School of Health Research Medallion for her work with Foetal Alcohol Spectrum Disorder.

# PROFESSOR FIONA STANLEY, AC FAA FASSA

#### Patron, Telethon Kids Institute Distinguished Research Professor, The University of Western Australia Vice Chancellor's Fellow, The University of Melbourne

Fiona Stanley is the Founding Director and Patron of the Telethon Kids Institute (formerly Telethon Institute for Child Health Research), Distinguished Research Professor at the University of Western Australia and Vice Chancellor's Fellow at the University of Melbourne where she was Director of the 2013 Festival of Ideas.

Trained in maternal and child health, epidemiology and public health, Professor Stanley has spent her career researching the causes of major childhood illnesses such as birth defects. Her research includes the gathering and analysis of population data for epidemiological and public health research; the causes and prevention of birth defects and major neurological disorders, particularly the cerebral palsies; patterns of maternal and child health in Aboriginal and Caucasian populations; various ways of determining the developmental origins of health and disease; collaborations to link research, policy and practice; and strategies to enhance health and wellbeing in populations. She pioneered the development, linkage and analysis of population level data and record linkage in Western Australia as a research and evaluation capacity.

Her major contribution has been to establish the Telethon Kids Institute, a unique multidisciplinary independent research institute focusing on the causes and prevention of major problems affecting children and youth, and to establish the Australian Research Alliance for Children and Youth. She has over 300 publications, books and book chapters, and is a board member of the Australian Broadcasting Corporation, a former member of the Prime Minister's Science, Engineering and Innovation Council, and has served on major international, national and local committees. For her research on behalf of Australia's children and Aboriginal social justice, she was named Australian of the Year in 2003, and in 2006 she was made a UNICEF Australia Ambassador for Early Childhood Development.

# ADJUNCT PROFESSOR MURIEL BAMBLETT AM

# Chief Executive Officer, Victorian Aboriginal Child Care Agency

Muriel Bamblett is a Yorta Yorta and Dja Dja Wurrung woman who has been employed as the Chief Executive Officer of the Victorian Aboriginal Child Care Agency since 1999. Muriel was Chairperson of the Secretariat of National Aboriginal and Islander Child Care for 10 years (the peak agency representing Indigenous Child and Family Services nationally). Muriel is active on many boards and committees concerning children, families and the Indigenous community, including the Victorian Children's Council; Our Watch (the Foundation to Prevent Violence Against Women and Children); the Australian Institute of Family Studies Advisory Council; the Aboriginal Justice Forum and the Aboriginal Community Elders Service.

Muriel has been the recipient of a number of awards, including the Centenary of Federation Medal; the 2003 Robin Clark Memorial Award for Inspirational Leadership in the Field of Child and Family Welfare; the Women's Electoral Lobby Inaugural Vida Goldstein Award; and an AM in the 2004 Australia Day Honours for her services to the community, particularly through leadership in the provision of services for Aboriginal and Torres Strait Islander children and families. In 2009 Muriel was appointed an Adjunct Professor at LaTrobe University's School of Social Work and Social Policy.

Muriel was inducted into the Victorian Honour Roll of Women in 2011 and was a finalist for a Human Rights Medal with the Australian Human Rights Commission.

#### Executive Director, First Nations Child and Family Caring Society of Canada Associate Professor, University of Alberta Director, FNCARES

A member of the Gitksan First Nation, Cindy has 25 years of social work experience in child protection and Indigenous children's rights. As Director of the First Nations Children's Action Research and Education Service (FNCARES) at the University of Alberta, her research interests are Indigenous theory and the identification and remediation of structural inequalities affecting First Nations children, youth and families.

Cindy's promotion of culturally based and evidence informed solutions has been recognized by the Nobel Women's Initiative, the Aboriginal Achievement Foundation, Frontline Defenders and many others.

# ANTOINETTE BRAYBROOK

### **Chief Executive Officer**

### Aboriginal Family Violence Prevention & Legal Service Victoria (FVPLS Victoria)

Antoinette Braybrook is CEO of Aboriginal Family Violence Prevention and Legal Service (FVPLS) Victoria since its inception. She is National Convenor National FVPLS Forum, delivering FVPLS Program to Aboriginal and Torres Strait Islander victims/survivors of family violence and sexual assault.

An Aboriginal woman born in Victoria on Wurundjeri country, Antoinette's grandfather and mother's line is through Kuku Yalanji, North Queensland. Antoinette graduated Deakin University with a Bachelor of Laws and admitted as legal practitioner in 2004.

Antoinette was awarded 2015 LIV's: Access to Justice/Pro Bono award and ACCW's 2015 Sustaining Women's Empowerment in Communities and Organisations Award.

# PROFESSOR PAT DUDGEON

#### Research Fellow, School of Indigenous Studies, The University of Western Australia, WA

Professor Pat Dudgeon is from the Bardi people of the Kimberly area in Western Australia. She is a Psychologist and Research Fellow at the School of Indigenous Studies at the University of Western Australia. Her area of research includes social and emotional wellbeing and suicide prevention. Amongst her many commitments, she is a Commissioner of the Australian National Mental Health Commission, on the executive board of the Australian Indigenous Psychologist's Association, and co-chair of the Commonwealth Aboriginal Torres Strait Islander Mental Health and Suicide Prevention Advisory Group. She is currently the project leader of the National Empowerment Project: an Indigenous suicide prevention project working with eleven sites in Aboriginal communities across the country. She has many publications in Indigenous mental health in particular, the Working Together Aboriginal and Torres Strait Islander Mental Health and Wellbeing Principals and Practice 2014. She is actively involved with the Aboriginal community and has a commitment to social justice for Indigenous people.

# MICK GOODA

# Aboriginal and Torres Strait Islander Social Justice Commissioner

Mick Gooda is a descendent of the Gangulu people of central Queensland and is the current Aboriginal and Torres Strait Islander Social Justice Commissioner. His term in this position commenced in February 2010.

Mick has a lengthy experience in Aboriginal and Torres Strait Islander affairs, having worked remote, rural and urban environments throughout Australia for over 30 years. He has a strong record of achievement in implementing program and organisational reform as well as delivering strategic and sustainable results across the country.

As Commissioner, Mick builds on this experience to advocate the human rights of Aboriginal and Torres Strait Islander peoples in Australia and then promote respect and understanding of these rights among the broader Australian community.

Andrew is a proud Yorta Yorta man, appointed in July 2013 as the inaugural Commissioner for Aboriginal Children and Young People (Victoria).

As Commissioner, Andrew is responsible for advocating for and oversighting the provision of state government services to Aboriginal children, particularly the most vulnerable in the areas of child protection and out of home care, education, health and the youth justice system.

Andrew is of the strong view that improving outcomes for the most vulnerable Koori children is intrinsically linked to their culture, intergenerational trauma from past government policies and improving the status and outcomes for their families and communities and neither can be separated.

For the previous 14 years he was an executive officer in the Department of Justice responsible for coordinating the Victorian Aboriginal Justice Agreement. He oversaw the growth of the Koori workforce from three in 2000 to employ well over 140, as well as establishment and growth of the Koori Court network within the Magistrate's, Children's and County court jurisdictions.

During his time at Justice, Andrew is most proud of the positive relationship developed between the Koori community and the Justice system, as represented by the Aboriginal Justice Forum and the supporting network of Regional and local Aboriginal Justice Advisory Committees.

Andrew is a member of the National Congress of Australia's First Peoples and the Aboriginal Justice Forum. In 2006 he was awarded the Public Service Medal and admitted as a Victorian Fellow with the Institute of Public Administration Australia (IPAA) and as an IPAA National Fellow in 2013.

# Judge, Federal Circuit Court of Australia Newcastle Registry

His Honour Judge Matthew Myers AM was appointed to the Federal Circuit Court of Australia in 2011 and is Australia's first and only Indigenous Commonwealth judicial officer.

Judge Myers holds a Bachelor of Arts, a Bachelor of Laws from the University of New South Wales, a Master of Applied Law (Family Law) from the College of Law and a Vocational Graduate Diploma of Family Dispute Resolution from Bond University.

Prior to his appointment, Judge Myers undertook work as a Notary Public, Accredited Collaborative Family Lawyer and as an Accredited Family Law Specialist with separate accreditation in New South Wales, Victoria and Queensland. Judge Myers had additionally worked in the area of family law mediation both as a Nationally Accredited Mediator and as an Accredited Family Dispute Resolution Practitioner.

Judge Myers was awarded the NSW Law Society President's medal in 2011 and received the award of Member of the Order of Australia in the Queen's Birthday Honours list in 2013 for services to the community in the area of welfare and Family Law.

Yarning Circle

## The SNAICC Conference program has identified some sessions as 'Yarning Circles'.

How are we defining 'Yarning Circle'? A yarn up or yarning is an Aboriginal term meaning to converse or have a conversation. A non-Aboriginal equivalent would be a discussion circle. # Keynote Address Professor Michael Chandler

Cultural Wounds Require Cultural Medicines: How Cultural Continuity Reduces Suicide Youth Risk in Indigenous Communities

This presentation will summarise a quarter-century of research into the health and wellbeing of a subset of Canada's First Nations communities. Youth suicide is taken as a marker of community distress, and the ongoing program of research to be described aims to search out distinctive features of those communities that enjoy low or absent youth suicide rates. The broad conclusion to which these data point is that those groups that enjoy remarkably lower rates of suicide are different from their more distressed counterparts by having achieved substantial measures of community control over their own cultural identity. More particularly, those communities that have sustained meaningful connections to their cultural past (i.e. language preservation; the maintenance of cultural rituals and practices; and the development of facilities to support cultural maintenance), and that are otherwise engaged in related practices meant to guarantee jurisdiction over their own cultural future (e.g. control over health and social service delivery; education; and matters of social justice) are just those communities with lower burdens of ill health, including youth suicide. Special attention will be focused on how such cultural control factors impact ongoing negotiations with governments and health delivery systems.







# **Keynote Address Professor Fiona Stanley**

Early Childhood: Overcoming Intergenerational Trauma for Aboriginal and Torres Strait Islander **Populations** 

The evidence around the impact of healthy pregnancies and early childhood development to provide for future health and wellbeing is now overwhelming. Psychosocial and neuroscience research shows clearly that brain development in the first 4 years is crucial for a range of capacities and capabilities. It also shows that negative influences have profoundly negative impacts early on children's future potential and poor health (such as alcohol, poor nutrition and stress). Early intervention focusing on parental empowerment has been shown to be particularly effective for disadvantaged groups if they are appropriate, intensive and long enough.


# **Keynote Address** June Oscar AO

Learning Across Worlds: Nurturing the Future of the Fitzroy Valley with New Practices in Early Life Education and Care

June Oscar AO, CEO of the Marninwarntikura Women's Resource Centre (MWRC) in Fitzroy Crossing will share her and her community's remarkable story of community led development, unheard of in Australia. In recent years, Marninwarntikura has become renowned for acting on the women's powerful convictions, through spearheading a movement which saw the enforcement of alcohol restrictions, leading to a ground-breaking study called Liliwan, which has recorded the prevalence of Foetal Alcohol Spectrum Disorders (FASD). The results are shocking; 21% of the region's children has been assessed to have one or many of the FASD related conditions.

The Liliwan study, conducted in partnership between the Fitzroy Valley community, the Telethon Institute, Sydney University and the George Institute for Global Health has given the women and their families the rigorous evidence base they need. The continued engagement between researchers and the community is enabling the Fitzroy Valley to become increasingly informed in how to respond to, care for and prevent children being born and growing with complex developmental conditions. These new multidisciplinary approaches to the education and therapy of children and families living with FASD are being practised in Marninwarntikura's Baya Gawiy Early Childhood Learning Unit.

Oscar's presentation encourages us to imagine a growing generation that is empowered to grasp all educational opportunities, no matter the challenges each child faces. As Oscar argues, it is diverse, creative and inclusive educations that have the power to unleash the boundless potential of youth, so an entire generation can walk together into a more promising and equal future.

### **Opening Plenary**

**Richard Walley & The Middar Dance Group** performance will involve traditional music and dance with the infusion of song and chants. Since the inception of 'Middar Aboriginal Theatre' in 1976 by Richard Walley and others, Middar has highlighted Noongar culture within 32 different countries. The group has collaborated with many Indigenous artists and performers worldwide including Native American, Native Canadian, Maori, African and South American clans. As well as contemporary artists like Carlos Santana, Stevie Wonder and The John Butler Trio.

### Moombaki Ensemble and Madjitil Moorna Choir (collaboration)

**Moombaki** (where the rivers meet the sky), are an eclectic ensemble of Aboriginal artists, who perform a mixture of their own songs and covers by various Aboriginal artists. The group's style is a mixture of contemporary & R&B, integrating spiritual influences and their own style of hauntingly beautiful and inspirational lyrics. The ensemble formed in 2015 and like their name suggests are from many rivers in life, they are performing artists in their own right and when they come together, their voices blend in beautiful harmonies, like an endless blue sky day. **Madjitil Moorna** is a unique community choir who sing Aboriginal songs, led by award-winning Aboriginal performers. They sing for better understanding, challenging old stereotypes as people from all backgrounds open their ears and hearts to explore Aboriginal culture, through song and story. Since 2006 the choir has performed throughout the Perth Metro area and in the East Kimberley. Audience participation is encouraged. Songs include contemporary and traditional songs, many in Aboriginal languages, including the Noongar language of the South West of WA.


### **Welcome Reception**

### Phillip Walley-Stack with Kwarbah Djookian Dance Group

From birth he has been exposed to a pocket of Aboriginal culture, maintained and passed on by his family since time began. Firmly entrenched in this tradition is the custom of storytelling - inseparable from song and dance. Phil performs both nationally and internationally and has performed in Germany, USA, Malaysia, Indonesia, France and Dubai. Kwarbah Djookian's Karla Hart, Melinda Eades and Tristen Parr will also join Phillip Walley-Stack in this performance.

She also sang for the half time performance for the West Coast Eagles vs. St Kilda match, performing for 40,000 people, which is her biggest gig yet! She looks forward to making more music and launching an album.

**Merindas** name comes from the Aboriginal Eora language – meaning beautiful woman and is a tribute to their Indigenous heritage. But there is far more to this very talented group than just their name. Candice, Kristel and Rhiannon are amazing performers whose stars are on the rise as they send ripples across Australia's Motown scene. In 2013 the group was nominated for a Deadly award in the category of 'Most Promising New Talent in Music'. They have supported some of Australia's biggest stars including Kasey Donovan, Christine Anu and Troy Cassar-Daley.

**Bartlett Brothers** are an Indigenous rock band from Perth that make music that touches the heart and spirit. They create rootsy pop rock sounds with soaring harmonies and a soul edge. Their music and lyrics are infused with the colours and themes of their home country and heritage.

The crew is facilitated by artist Fleur Hockey and co-facilitator Karla Hart. These young people love to dance and look forward to sharing their 'dardy' moves with you!

### **Corroboree: Closing Event in the Summer Garden**

Join us outside at the Perth Convention Centre's Summer Garden to celebrate the closing of the Conference with a unique experience featuring sand art and local groups participating in a Corroboree. Participants will include:

**Boodja Bidi** – In 2013 the Guildford Grammar School (WA) formed its own Indigenous Dance Troupe – Boodjar Bidi – meaning country pathways/country tracks. Each of the Guildford Grammar School's Indigenous students is creating their own tracks during their time at the school. The more they continue on their path, the sooner it will become a permanent track where other people from their community will be able to follow in their tracks.

Jim Webb and Wadumbah Dance Group – Traditional Bibbulmunn Aboriginal dance and music performed with fun, passion and power! Wadumbah brings the Dreaming stories of the very first Australians alive in a performance that's authentic and spectacular. Wearing traditional Aboriginal costumes, enhanced by awesome Didjeridoo playing and the hypnotic rhythm of the tapping sticks, skilful performers and traditional presentation will entertain and enthral your audience.

**Kwarbah Djookian**, meaning beautiful sisters in Noongah language, is an Aboriginal women's dance group who have been dancing together since late 2007 and are based in Perth. Kwarbah Djookian feel privileged to share with you dances and songs that have been passed on to them by their elders and the group are passionate and proud of their Indigenous culture. This performance is a spiritual experience that will take you to a special place and must not be missed.

**The Moorditj Mob** is Wesley College's Indigenous Program. The program is an important part of the culture at the College and something the Wesley community has great pride in. The program currently supports 45 students from across Western Australia. Moorditj is the Nyoongar word meaning great or excellent and fits well with what the College strives to achieve. The program offers cultural education and develops pride and understanding in identity that complements a mainstream education. Nyoongar students celebrate this pride in dancing and enjoy performing and teaching primary school students about culture. Last year they performed over 40 dances to different groups. They have met and performed for Sir Bob Geldof, danced in the National NAIDOC Week Opening Ceremony and at the Western Australian Youth Awards ceremony at Crown Entertainment Complex. The boys recently returned from the World Indigenous Peoples Conference in Education in Hawaii where they performed 5 times, including the opening and closing ceremony.

Little Doorum is a traditional youth dance group that consists of the sons and nephews of members of the Doorum Dancers. The name of the group comes from their great grandfather "Doorum" who was a leader of the people from the Baladong clan group. Little Doorum perform for festivals and schools throughout the southwest region and also participate in workshops run by older members of the group. With an average age of nine and the youngest at three, Little Doorum are very confident and possess a strong sense of pride.

**SAND ART by Nerolie Blurton** – As part of the Corroboree, artist Nerolie Blurton will be creating the design below with sand art. The design features a large wavy flower which are native hibiscus flowers starting to show around, with the circles inside which are the yellow acacias. The children are playing, they are represented as spirit people for the past, present and future. Symbols of animal tracks of the inland animals hunted in Djilba, kangaroo, emu and possum. Children all joined to the circle in the middle surrounded by the flowers in Djikba season. A waterhole is featured in the centre, which will now be receiving some rain on and off.

Nerolie Edith Blurton (nee Bynder) is a proud Badimia, Yamaji, Noongar woman born in the Three Springs, WA. She is a mother to five sons and a baby daughter and has been interested in art from a young age but only started to sell her works from 2010. Nerolie's inspiration comes from life journeys, family life, Elders and her mother's artistic outlook. She finds painting calming, healing and strengthening and likes to use bright colours to express her works and create art that is enjoyed by many.
